# Episode 15: Adel Manna: The Nakba as History and Trauma

**Guest:** Professor Adel Manna – Van Leer Jerusalem Institute

**Bio:** Professor Adel Manna is a leading scholar of modern Palestinian history, renowned for integrating meticulous archival research with Palestinian oral histories and family narratives. He is the author of the landmark study *Nakba and Survival*, and together with Jewish-Israeli historian Prof. Motti Golani, coauthored *Two Sides of the Coin: Independence and Nakba 1948*, a seminal work exploring the contested history of Israel's independence and the Palestinian Nakba. His research exemplifies how sensitive historical truths can be approached with rigor, empathy, and respect for multiple perspectives.

In this Episode: Recorded in Berlin's Neukölln district, home to Germany's largest Palestinian diaspora, this episode explores the most painful chapter in Palestinian history, preceding the current devastation in Gaza. It opens with Prof. Adel Manna's family history, beginning with his father, who as a child witnessed an atrocity in his Palestinian home village of Majd al-Kurum. Prof. Manna reflects on growing up navigating conflicting narratives as a Palestinian in Israel. The conversation traces the events of 1947 and 1948 from a Palestinian perspective, focusing on the Nakba - its causes, consequences, and lasting impact on Palestinian families and collective memory. Key topics include the displacement and dispossession of communities, Palestinian refugees, and the contested interpretations of Plan Dalet - seen by most Israeli scholars (e.g. Benny Morris) as a defensive military plan, but regarded by many Palestinian historians as a blueprint for displacement. Prof. Manna also discusses the preservation of memory through family stories and oral histories. Listeners gain insight into why the Nakba remains deeply significant for the Palestinian community today, how historical truths are contested and negotiated, and why these stories continue to be vital in contemporary discussions of justice, identity, and memory in the region.
