Episode 22: How Antisemitism Has Shaped the World

Guest: Prof. Dr. Magda Teter, Chair of Judaic Studies and History, Fordham

University; President, American Academy of Jewish Research

Bio:

Professor Magda Teter is one of the most respected contemporary historians of antisemitism. She was recommended by David Nirenberg, whose work is foundational for understanding how antisemitism has shaped Western thought, to cover this essential segment. Her scholarship illuminates the historical roots and enduring systemic impact of antisemitic tropes. She is the author of *Christian* Supremacy: Reckoning with the Roots of Antisemitism and Racism (2023) and Blood Libel: On the Trail of an Antisemitic Myth (2020), which won the National Jewish Book Award, the Ronald Bainton Prize (2021) from the Sixteenth Century Studies Society and the George L. Mosse Prize from the American Historical Association (2021) that is awarded once a year to "an outstanding major work of extraordinary scholarly distinction, creativity, and originality in the intellectual and cultural history of Europe since 1500." Professor Teter has received prestigious fellowships, including from the John Simon Guggenheim Memorial Foundation, the Harry Frank Guggenheim Foundation, and the Radcliffe Institute for Advanced Studies at Harvard University. She has served as co-editor of the Association for Jewish Studies Review and as Vice-President for Publications of the Association for Jewish Studies. She is currently President of the American Academy for Jewish Research.

In this Episode:

In this episode, Professor Magda Teter takes listeners on a comprehensive journey through the history of antisemitism, tracing its origins from ancient times to the present. She examines how early antisemitic narratives, including the infamous blood libel myth, evolved under the influence of Christian theology and persisted across centuries, shaping Western thought and societal structures to this day. The discussion explores the development of conspiracy theories about Jewish power, the interplay between antisemitism and racism, and the concept of Christian supremacy as a framework for understanding the systemic nature of antisemitism. Professor Teter also addresses contemporary forms of antisemitism, including how they manifest in anti-Israel discourse, the challenges of defining antisemitism in modern contexts, and its manifestations beyond the Western world. The conversation further reflects the role of christian institutions in perpetuating prejudice, the persectutions that led to the rise of Zionism, and historical continuities and ruptures leading to the Holocaust. Prof. Teter is offering listeners both a historical perspective and critical tools to understand antisemitism today without centering perpetrators.

Transsubstantiation & the Blood Libel Myth

In this episode, Magda Teter connects the blood libel myth to the Catholic belief in transubstantiation. This is a technical term from Catholic theology referring to the central ritual of the Mass, a religious service, during which bread and wine are shared in remembrance of Jesus' Last Supper before his death. Catholics believe that, through this ritual, the bread and wine are transformed into the body and blood of Christ, even though they retain the appearance of bread and wine. Because this ritual is considered essential for salvation, medieval Christians imagined that Jews desecrated it by using the blood of innocent children. This accusation built on the oldest anti-jewish claim - that Jews were responsible for the death of Jesus. Over time, the blood libel became one of the most enduring antisemitic myths, with echoes that persist today in portrayals of Jews as deliberate child-killers.
