Episode 51: Young Ambassadors for Peace - Parents Circle Families Forum

Bios: Sima and Mai are Young Ambassadors for Peace with the Parents Circle – Families Forum (PCFF), an organization of over 800 bereaved Israeli and Palestinian families who have each lost a close family member to the conflict. Mai lost his grandfather, Haim Perry, an artist and well-known peace activist from Kibbutz Nir Oz, who was abducted and killed during the attacks of October 7, as well as his cousin Daniel Darlington, who was killed at the Nova Festival. Sima lost her 14-year-old brother to the conflict, a loss that profoundly affected her family. Despite these immense personal tragedies, both Sima and Mai have chosen to dedicate themselves to reconciliation and dialogue. They are moral leaders, carrying their grief while actively promoting peace, understanding, and coexistence. Through the Young Ambassadors program, they bring this message to schools and communities in Israel, Palestine, and beyond.

In this final episode: We want to listen from the heart. The first and last words of this podcast belong to the innocent people who live and die in Israel and Palestine. We wanted to begin and end this series with the human reality of the conflict, so that as witnesses to the devastating violence since October 7, we never forget that real people live, grieve, and endure on both sides. Their stories, their losses, and their profound resilience have been the inspiration for this journey. The young olive tree on our podcast cover, growing in the middle of a desert, is a symbol for the hope young ambassadors for peace like Sima and Mai bring to Israel and Palestine, the wounded and "magical land between the river and the sea" (Mai) that they both call home.

For her scholarly achievements as a historian, she was awarded the *Preis des Historischen Kollegs* in 2025, the highest distinction in her discipline in Germany.
